9. Special Resolution to amend Article 9 of the existing Articles of Association to say:

"The Board shall meet as soon as practicable immediately after each AGM to appoint the Office-Bearers from the Board (all or any of whom can be Co-opted Trustees), usually being the President, Vice President, Secretary and Treasurer. Grenville Johnston referred to the regular updates to members in the Newsletters, and said that for this reason, reports from the individual committees would not be included this AGM. He highlighted the following activities and achievements for the year:

- Moray Council no future financial assistance will be received. This response provoked a number of substantial donations.
- Outreach/education Di Hannan was thanked for her work with schools and groups. An innovation was a Museum takeover by two Primary Schools.
- Thanks were also given to Heather Townsend (Museum Assistant), to the members of the Management Committee who all have specific responsibilities, and to all the volunteers. A full programme of activities and lectures was arranged for 2015/16.
- In addition to our usual changing displays, including WWI/1916, we hosted "Unknown" by Alison Kinnaird, and received the Dandaleith stone.
- New volunteer activity has included the Geology and Library Groups, and with the Birds and Eggs recatalogued, a start on the Butterflies and Moths. An innovation was a coach trip for volunteers to the archaeology of Aberdeenshire.
- Opening day was a great success, thanks to Windy Miller, and Johnny and the Copycats.
- CARS funding we still have not found the required 50% funding.

6. Financial report – see statement of income/expenditure and balance sheet to year end 31/12/2015 (Extracts from full accounts examined by Ritsons and almost ready for presentation to OSCR – full copies can be seen on request or on the OSCR and Companies House websites.) In summary, while our finances show a modest surplus in unrestricted funds, we still require to have some £50k annually to run the museum, and our utility and maintenance costs increase. The majority of our funds are restricted and not available for general maintenance and outgoings. Apart from the salaries of the part-time Museum Assistant and Janitor, any wages are funded from project grants. Donations have been most welcome, but they are unpredictable.
